

Statements required in notice if the proposed tax rate does not exceed the lower of the no-new-revenue tax rate or the voter-approval tax rate, as prescribed by Tax Code §26.061.

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.013947 per \$100 valuation has been proposed by the governing body of TEMPLE HEALTH AND BIOSCIENCE.

PROPOSED TAX RATE: \$0.013947 per \$100

NO-NEW-REVENUE TAX RATE: \$0.013947 per \$100

VOTER-APPROVAL TAX RATE: \$0.015122 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for TEMPLE HEALTH AND BIOSCIENCE from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that TEMPLE HEALTH AND BIOSCIENCE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that TEMPLE HEALTH AND BIOSCIENCE is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON 09/10/2025 11:45 AM (CT) at TEMPLE ECONOMIC DEVELOPMENT CORPORATION, 201 SANTA FE WAY, SUITE 103, Temple, TX.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, TEMPLE HEALTH AND BIOSCIENCE is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the TEMPLE ECONOMIC DEVELOPMENT CORPORATION of TEMPLE HEALTH AND BIOSCIENCE at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by TEMPLE HEALTH AND BIOSCIENCE last year to the taxes proposed to be imposed on the average residence homestead by TEMPLE HEALTH AND BIOSCIENCE this year.
